**AGREEMENT**

I acknowledge the "Rules Applying to Dog Shows" and "Rules Applying to Registration and Discipline" and "Obedience Regulations" and any applicable rules of the WGS DCA, Inc. I agree to hold the WGS DCA, Inc. and any WGS DCA approved judge HARMLESS from any legal claim resulting from said Judge's action under the Rules, Regulations, and Guidelines. I agree that the club holding this show or obedience trial has the right to refuse this entry for cause which the club shall deem to be sufficient in consideration of the acceptance of this entry and of the holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies. I agree to hold this club, its members, directors, governors, officers, agents, superintendents, or show secretary, and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or grounds or near any entrance thereof, and I personally assume all responsibility and liability for any such claim, and I further agree to hold the aforementioned parties harmless from any such claim for loss of this dog by disappearance, theft, damage, death, or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I hereby assume the sole responsibility for and agree to indemnity and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself, or on account of damage to property, arising out of or in consequence of my participations in this show or obedience trial, howsoever such injuries, death, or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees, agents, or any other persons.

**INSTRUCTIONS**

1. A dog MUST be entered in the name of the person who actually owns the dog at the time of entry. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in the show for which entries closed AFTER the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether the transfer application has been mailed to the AKC (For complete rule, refer to Chapter 11, Section 3)

2. Use this form for all-breed obedience trials for dogs not entered in conformation shows. If a WGS D is entered in a conformation show and wished to compete at the accompanying obedience trial, the obedience class may be entered on the conformation entry form.
